Awards: Ribbons will be awarded for all passing searches, including placement ribbons for 1st-4th place. Rosettes will be awarded for High In Trial, Jr. High In Trial, and New Titles.

Move-up Policy: Move ups are allowed between trials.

Substitution Policy: No substitutions will be allowed at these trials.

Refund Policy: Entry fees will not be refunded in the event a dog is absent, disqualified, excused by judge or veterinarian, barred from competition by action of the show committee or UKC. No fees will be refunded if the show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of god, public emergency or any other cause beyond the control of the show committee. Refunds will be given for bitches that come in season after the closing date of the trial minus a \$5.00 handling fee with a veterinarian's certificate prior to the start of the trial.

Show Photographer: No Show Photographer will be provided. Exhibitors may choose one or two people to accompany them into the search area during the running of their dogs to video and/or photograph their performance. These people must remain in a designated area during the entire performance, with minimal movement (only movement required to video or photograph the run). Any interference or negative effect that results in a non-qualifying performance due to the additional people brought in by the handler will not be allowed a re-run. All videos are to be kept private until the completion of the trial, and all placements have been awarded for that trial.

1. Nosework trials will include a pre-trial for the levels being run. Dogs need to pass the pre-trial for the level they are competing in. Dogs may be entered prior to passing, but must pass the pre-trial prior to competing that day. If the dog has passed on ORT in the applicable odor please submit a copy of proof.
2. Individual element classes are divided into Levels “N”-“E” and further divided into “A” and “B” sections depending on the experience of the dog and/or handler. Be sure to check the rules regarding the divisions. For these classes, dogs will only be searching the elements chosen.
3. Full Nosework Trials are divided into Levels “N”-“E” and further divided into “A” and “B” sections depending on the experience of the dog and/or handler. These trials contain all four elements. Each element passed earns a leg toward a title in that element.
4. Handler Discrimination. One glove will be used and must be provided by the handler.
5. All entries must be submitted on the current “Official UKC® Nosework Trial Entry Form”.
6. Use a separate entry form for each dog entered in a club's event.
7. Nosework events are open to all UKC registered breeds and mixed-breed dogs with a valid Performance Listing/Limited Privilege number/Permanent Registration/Temporary Listing.
8. We want you to keep the points earned at UKC Licensed events. Important things to remember:
 - All dogs entering UKC events must be permanently registered, have a valid Temporary Listing Number, or a Performance Listing/Limited Privilege number.
 - Dog not UKC registered? Apply for a Temporary Listing Number (TL) online at www.ukcdogs.com/tl-numbers. (TL fees are non-refundable, non-transferable and do not apply to the cost of permanent registration.)
 - All entry forms must be completed and signed. Incorrect information submitted on the entry form may invalidate your wins.
9. The United Kennel Club complies with the Americans with Disabilities Act. If you require an accommodation, please contact the Event Chair or Secretary for this club’s event.
