#### A and B Classes

"A" classes are for teams that have not yet completed their title at that level. "B" classes are for teams that have already completed their title at that level.

There is no A/B option in Intro; teams that have earned the RL1 or RLI title are ineligible for placements in Intro but may compete.

#### **Specialty Classes (games)**

We will not be offering specialty classes at this event.

We will have two non-titling specialty classes at this event. Results do not count for titles, but we will award placement ribbons and prizes to the top five finishers. Both games can be done on or off leash. Food rewards can be given during the game for any stationary position (same as Intro class rules). Teams must be registered with WCRL to enter the game, but need not be showing in any other class.

**Trial 1 game (Kaleidoscope)**: Signs will be arranged around the ring and marked with different colors to indicate different point values. Teams will have 2 minutes to gain as many points as possible. Teams will get 10 points for each sign with points deducted for errors using standard scoring. Points are deducted for out of position errors between signs. Signs may be taken from all levels; one color will only be available for teams working off leash. Signs can be taken as many times as desired for flow, but only can be performed 3 times for points. Placements will be determined by highest points gained.

2) "Bank It" Numbered course, teams earn the number of points on the sign (so 1 for first sign, 2 for second, etc). Option to "bank" points at any time by heeling back to the start via a cone path. Teams lose all unbanked points for any error that would result in a deduction of more than 1 point and must return to the start before continuing (judge will announce point loss so team knows to restart).

#### **Jump Heights**

Dogs are not required to be measured the day of the trial or prior to judging. However, judges have the option of measuring any dog prior to his/her performance if the dog appears to be entered in a group lower than might be indicated by his or her registered shoulder height. Jump heights may also be modified or the jump exercise excused entirely based on physical challenges (e.g. age, disability such as blindness, or use of a mobility device) that a particular dog may face.

#### **Notice to Competitors**

Competitors, through submission of entry, acknowledge that they are knowledgeable of WCRL Rally Obedience rules and regulations including but not limited to the following rules regarding entry:

This trial is open to a dogs at least six months of age, including purebred and non-purebred, except bitches in season or dogs with disabilities, injuries, or illnesses which may cause the dog pain or great discomfort, or dogs exhibiting signs of aggression that threaten the safety of other dogs or humans.

All dogs must be registered with WCRL Rally to compete. A one-time registration form is available and must be submitted DIRECTLY to the Rally-O Coordinator (NOT to the trial hosting organization) before the date that a team first submits an entry in a sanctioned trial. We regret we cannot accept an entry without a valid WCRL Rally registration number. See www.rallydogs.com to register online or by US Mail.

Dogs must be shown by a member of the owner's immediate family: mother, father, spouse, life partner, sibling, child, grandparent, or grandchild.

Safety shall always be of foremost consideration in actions and conduct by handlers at all times. Handlers, through entry at this event, accept full responsibility for themselves and the actions of their dogs.

The organizing committee may refuse any entry for any reason.

THERE SHALL BE NO REFUND for entries withdrawn after the closing date or in the event a dog and/or handler are dismissed from competition, regardless of reason for such dismissal. A dog or handler who suffers an injury and/or illness or bitches that come into season after the closing date may be eligible for a 50% refund of their total entry fee. Written request for a 50% refund must be made to the Trial Secretary BEFORE the end of the event. Please provide documentation from your veterinarian/physician. There will be no refunds if the trial has to be cancelled for any reason. No entry fees will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, Act of God, public emergency, act of a public enemy, strike, or any other cause beyond the control of the organizers.

Returned checks do not constitute a valid entry. There will be a \$25.00 service charge for returned checks. Payment of entry fees and service charges shall be made in cash or money order within 30 days of postmark of notice of returned check where notification is received after event date. Any unpaid fees or shortfalls must be paid prior to the start of the event or entry is cancelled without recourse by owner/handler.

Online entries are valid immediately if paid by credit card. Entries made by online registration not paid by credit card are not guaranteed until a check is received by mail (requested runs will be held for 3 business days). All dogs shall be shown in a flat buckle or snap collar, plain harness, or properly fitted martingale (limited slip) collar. No choke collar, prong collars, shock collars, no-pull harnesses, martingale leads, or head collars are allowed; these collars are not permitted on trial grounds.

All competitors through entry at this event waive any and all rights relative to video broadcast of this event. Competitors shall have the right to videotape portions of this event for their personal use only. No portion of this event may be videotaped for commercial or other purposes. All video, broadcast, and telecast rights for this event are the exclusive property of the WCRL or the trial host(s). Owners with disabilities are encouraged to compete. Any necessary modifications to the exercises must be provided by the handler to the judge and approved by the judge.

Upon successful completion of a Stationary exercise, the owner may choose to briefly pet or touch the dog as a reward. The owner may also choose to give the dog food as a reward. Food may NOT be used as a lure to help the dog complete an exercise. Food rewards must be contained in pockets and only be present in the owner's hand at the completion of a Stationary exercise. Any petting, touching, or feeding that significantly interrupts the flow of performance shall be scored accordingly. Intro classes allow food rewards to be used more liberally; see the official rules for more details.

Dogs must remain under control at all times whether on or off leash while on trial site grounds. Please pick up after your dog and yourself.

#### **Entries and Closing Date**

**Entries Open Immediately** Entries submitted via FedEx or Express Mail will be accepted only if the signature waiver is signed. No telephone, email, or fax entries will be accepted; Online entries available at <a href="https://www.posidog.org">www.posidog.org</a>

#### **Closing Date**

Entries must be received no later than the closing date stated on the first page. Day of Trial Entries will be accepted if the trial is not full.

#### Awards

Flat ribbons will be provided for all qualifying scores. Placements 1-5 in "A", "B", and "Intro" classes will receive double layered flat ribbons. Titling Rosettes will be provided for teams finishing Intro, RL1, RL2, and RL3 titles. Rosettes are available for all first championship titles.

First place "A" and "Intro" class dogs will get a voucher for \$10 off entries at a future PosiDog WCRL trial. Additional vouchers for discounted entries will be given to "A" and "Intro" class 2nd and 3rd place and to 1st-3rd place in "B" classes.

#### Trial Times, Briefing, Walk Through

Judges' briefings and walk-throughs will precede each class.

The first trial each day will start at the time posted on the first page. Specific information will be provided to competitors at least one week prior to the trial. Second trial will follow the first.

#### **Trial Check In and Crating**

PosiDog Canine Learning Center will be open to rally competitors at least 30 minutes prior to the start of the trial. More information will be provided closer to the trial about exact times.

Park at the front door to unload crates and we will direct you to an additional parking area. If you are crating out of your car, there is limited parking reserved at the front door.

Dogs may be crated in PosiDog. Please bring something to put on the floor under your crate to help protect the floor.
